The Quality Control Inspector will be responsible for conducting QCI Final Inspections on all units completed under the current PY 2019- PY 2020 DOE contracts. The BVCAP Weatherization Staff will be responsible for overseeing all other aspects of Weatherization work, including the initial inspection, energy audits, work-order, project oversight, and pre-final inspections of all completed weatherization work.

The BVCAP Weatherization service area includes the counties of Brazos, Burleson, Grimes, Leon, Madison, Montgomery, Robertson, Walker, Waller and Washington. BVCAP estimates that a minimum of 15-20 units will be required to be inspected by a certified Quality Control Inspector during this contract period within the 10-County service area.

BVCAP reserves the right to reject any or all quotes, or any part thereof, to waive irregularities that it considers nonmaterial to the quote, and to award the quote solely as it deems to be in the best interest of the Organization.
